WAIVER AND RELEASE

I agree to promptly pay all costs associated with such treatment. I further agree to indemnify, defend and hold harmless Fit for a Dog, its agents, employees, members and contractors from and against any and all claims, demands, costs, damages and suits (including attorneys' fees and court costs) incurred or suffered by Fit for a Dog, its agents, employees, members and contractors as a result of any such illness or injury or the treatment thereof.
- 2. Fit for a Dog shall not be responsible for any injury to or damage to my dog while it is in the care of Fit for a Dog and I hereby release and discharge and covenant not to sue Fit for a Dog, its agents, employees, members and contractors and agree to indemnify, hold harmless and defend Fit for a Dog, its agents, employees, members and contractors from and against any and all such claims.
- 3. I will be solely responsible for all actions of my dog, including any damage caused by my dog and any injury caused to other dogs, people or property while in the care of Fit for a Dog and agree to indemnify, defend and hold harmless Fit for a Dog, its agents, employees, members and contractors from and against any and all claims, demands, costs, damages and suits (including attorneys' fees and court costs) incurred or suffered by Fit for a Dog, its agents, employees, members and contractors as a result of the actions of my dog including but not limited to any damage or injury to or caused by my dog.
- 4. My dog is in good health and is suitable to be in the care of Fit for a Dog and in the presence of other dogs. My dog has not exhibited any aggression toward people or other animals and my dog will comply with instructions.
- 5. I acknowledge that my dog will be in the presence of other dogs and that such environment involves risks regarding illness and disease. I recognize that such risk is an inherent part of the services offered by Fit for a Dog. I hereby release and discharge Fit for a Dog, its agents, employees, members and contractors from and against any and all claims, demands, costs, damages and suits (including attorneys' fees and court costs) incurred or suffered by Fit for a Dog, its agents, employees, members and contractors which relate to or arise from any illness or injury (including but not limited to death) which my dog may suffer while in the care of Fit for a Dog.
